1. Open vial according to enclosed instructions.
  2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.
  3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
  5. Incubate the tubes and plate at 37°C for 48 hours.

### **Notes**

On #260 plates colonies are round, smooth, glistening, entire and white.
