Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #573 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #573 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary

broth tube to these secondary tubes.

3. Use several drops of the primary broth tube to inoculate a #573 plate.
  4. Incubate at 50°C for 2-3 days.
