Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #1065 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
4. Use several drops of this suspension to inoculate a second tube of broth, a slant, and/or a plate.

5. Incubate all tubes and plate at 30°C for 24 hours.

Notes

Colonies on #1065 plates are entire, glistening, slightly irregular, undulate, and translucent.
