Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### Handling Procedures

1. Open vial according to enclosed instructions.

2. Under anaerobic conditions, withdraw 0.5 ml of #1500 broth from a single test tube (5 to 6 ml) and rehydrate the entire vial contents.

3. Aseptically transfer this aliquot back into the broth tube. Additional tubes may be inoculated with 0.5 ml each from the suspension. Streak several blood plates to

check for colonial morphology and purity.

#### Notes

In 24 to 48 hours, growth is evident by turbidity and strong gas formation in the broth and by colonies that are 0.5 to 1.0 mm in diameter on the anaerobic agar surfaces. No growth should occur on agar plate incubated aerobically.
