### **Handling Procedures**

1. Open vial.

2. Using a single tube of #5129 (5 to 6 ml), withdraw 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet. Aseptically transfer this aliquot back into the broth tube. Mix well.
3. Aseptically transfer 0.2 ml of this suspension to additional #5129 broth tubes, #814 slant(s) and/or 0.1 ml to plates.
4. Incubate tubes and plates at 37°C in an atmosphere of 5% CO<sub>2</sub>.
5. Within 24 to 48 hours, growth is evident by colonies on the agar surfaces.

### **Notes**

This strain is Beta-lactamase positive.
