Handling Procedures

- 1. Open vial.
- 2. From a single tube of #416 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well
- 4. Use several drops of this suspension to inoculate a second tube of broth, a

slant and/or a plate.

5. Incubate tubes and plate at 37° C in an atmosphere of 5% CO₂ for 24 to 48 hours. Loosen screw caps of all test tubes during the incubation period.

After 24-48 hours growth is evident by turbidity in the broth and the formation of dull, dry, slightly opaque, wrinkled colonies with flat edges becoming erose.
