Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## **Handling Procedures**

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #1507 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #1507 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary

broth tube to these secondary tubes.

3. Use several drops of the primary broth tube to inoculate a #1507 plate and/or #1507 agar slant.
4. Incubate at 37°C for up to 4 weeks.
