## Handling Procedures

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #1565 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #1565 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary

- broth tube to these secondary tubes.
3. Use several drops of the primary broth tube to inoculate a #1565 plate and/or #1565 agar slant.
  4. Incubate at 26°C for up to a week.
