Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### Handling Procedures

1. Thaw the frozen vial at room temperature.

- 2. Under anaerobic conditions, aseptically transfer the contents of the vial into a tube of the recommended broth (5 to 6 ml).
- Additional tubes may be inoculated with 0.5 ml each from the suspension. Also,
   0.1 ml may be inoculated onto a slant. Streak a Brucella blood plate and/or
   #260 agar plate to check for colony morphology and a blood plate to check for purity.
- 4. Incubate tubes under an anaerobic atmosphere at 37°C. Incubate the Brucella Agar plate anaerobically for colony formation, and the blood plate aerobically for aerobic contamination check.
- 5. Within 48 hours, growth should be evident by turbidity in the broth and by colonies on the anaerobic agar surfaces. No growth should occur on agar plates incubated aerobically.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.
