For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

ATCC Medium 1099: CYE (Charcoal Yeast Extract) Buffered Medium

Temperature: 37°C

Atmosphere: 95% Air, 5% CO₂

Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #1099 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate an agar slant and/or plate.



5. Incubate at 37°C in an atmosphere of 5% CO₂ for 48-72 hours.

Notes

Several GenBank accessions are available for this item:

- 2. Nucleotide (GenBank): Z24698 L.pneumophila 23S and 5S rRNA genes, partial CDS's.

Legionella species are nutritionally fastidious and are inhibited by media of poor caliber, so strict attention should be paid to the quality of the ingredients. The pH of the medium should be checked when cool, and is most critical. Unbuffered medium should not be used. Exposure of medium to light, particularly when hot, may also result in the accumulation of peroxides that can be inhibitory to the bacteria.

Before rehydration, vials may be stored at +2 to +8°C for extended periods with minimal loss of viability. Subculturing to maintain culture is discouraged because of the possibility of mutation, selection of variants, or contamination. To minimize changes, it is recommended that cells be harvested and stored at -70°C or below.
