Escherichia coli strain CDC B170 is a whole-genome sequenced non-toxicogenic enteropathogenic *E. coli* (EPEC) confirmed by PCR to carry the *eae* gene and be negative for the *stx1* and *stx2* genes.

Handling Procedures

1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #18 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #18 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
3. Use several drops of the primary broth tube to inoculate a #18 plate and/or #18 agar slant.
4. Incubate at 37°C for 24 hours.

Notes

ATCC Medium 3: Nutrient agar/broth can be used as an alternate medium.

This strain was confirmed by PCR to carry the *eae* gene but not the *stx1* and *stx2* genes (*stx1*-, *stx2*-, *eae*+).
