*Escherichia coli* strain CDC EDL 1284 [929-78] is a whole-genome sequenced enteroinvasive *E. coli* (EIEC) and was isolated from human feces. This strain is serotype O124:NM and contains a high-molecular-weight plasmid responsible for enteroinvasiveness.

## Handling Procedures

1. Open vial according to enclosed instructions.

2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
  3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
  5. Incubate the tubes and plate at 37°C for 24 hours.
