Description

Escherichia coli strain CDC EDL 933 was isolated from raw hamburger meat implicated in a hemorrhagic colitis outbreak. This whole-genome sequenced bacterial strain is serotype O157:H7 and produces Shiga-like toxins I and II.

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0

- mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 12 to 24 hours.
