Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

ATCC Medium 343: V8 juice agar

ATCC Medium 336: Potato dextrose agar (PDA)

Temperature: 24-26°C

Atmosphere: Aerobic

Handling Procedures

For **freeze-dry (lyophilized)** ampoules:

1. Open vial according to enclosed instructions.
2. From a single test tube of **sterile distilled water** (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a sterile pipette and apply directly to the pellet. Stir to form a suspension.

3. Aseptically transfer the suspension back into the test tube of sterile distilled water.
4. Let the test tube sit at room temperature (25°C) undisturbed for **at least 2 hours**; overnight rehydration is recommended.
5. Mix the suspension well. Use several drops to inoculate recommended solid or liquid medium.
6. Incubate cultures at recommended temperature.

Morphology: After 3 days on V8 agar at room temperature with a natural day/night cycle, colonies cream-colored, becoming grey, velutinous or floccose, reverse dark uncolored or dark brown. Conidia straight, cylindrical with rounded ends, 3 septate, brown.

Notes

May require natural light for sporulation.
