## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
  5. Incubate the tubes and plate at 30°C for 48 hours.

## Notes

Broth shows heavy yellow sediment.

Colonies are circular, entire, glistening, smooth and translucent.

The yellow pigment, which is characteristic of this strain, is evident on Tryptic Soy Medium but not on Nutrient Agar (BD 213000).
