1. Open thawed vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Aseptically transfer the entire contents to a tube of 5-6 mL #1675 broth. Additional broth tubes can be inoculated by transferring 0.5 mL from the primary broth tube to secondary broth tubes.
3. Use several drops of the suspension to inoculate a #1675 agar slant and/or

plate.

4. Incubate the tubes and plate at 37°C for 24 hours.
