Fusobacterium nucleatum subsp. *vincentii* strain EM48 is a bacterial type strain that was isolated from a human periodontal pocket. This strain is propagated anaerobically.

ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Medium:

ATCC Medium 1490: Modified chopped meat medium

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 37°C

Atmosphere: Anaerobic

Handling Procedures

1. Open vial.
2. Under anaerobic conditions, withdraw 0.5 mL of recommended broth from a single test tube (5 to 6 mL) and rehydrate the entire vial contents.

3. Aseptically transfer this aliquot back into the broth tube. A slant and a Anaerobe Systems Brucella Blood plate (AS-111 or AS-141) plate may also be inoculated with 0.1 mL each of the cell suspension. An aerobic Brucella blood plate may also be streaked to check for purity.
4. Incubate tubes and plate under anaerobic conditions at 37°C. Incubate the Brucella blood plate aerobically at 37°C.
5. In 24 to 48 hours, growth is evident by turbidity in the broth.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

Notes

For the analysis of colony morphology and purity, ATCC recommends the Anaerobe Systems Brucella Blood Plate (AS-111 or AS-141). ATCC Medium #260 plates are also an acceptable medium for viability and purity testing.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions. Resazurin in the media is a color indicator for anaerobic conditions. Observance of pink color in medium before use or during incubation shows anaerobic conditions have not been met and oxidation has occurred. Medium should be discarded.
