## **Handling Procedures**

- 1. Open vial according to enclosed instructions.
    2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
    3. Aseptically transfer this aliquot back into the broth tube. Mix well.
    4. Use several drops of the suspension to inoculate a #44 agar slant and/or plate.
    5. Incubate the tubes and plate at 37°C for 24-48 hours.

## **Notes**

Two colony types are observed on sheep blood agar: a) smooth, translucent, butyrous, circular, entire; and b) irregular, umbonate, undulate. Both colony types display alpha hemolysis. Colonies will appear more uniform on #44 plates.
