Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.
3. Aseptically transfer this aliquot back into the broth tube and mix well. Transfer 0.5 ml to a second broth tube and mix well. Transfers to solid media can be made from

the second tube.

4. Incubate broth tubes, slants and plates at 22°C for 48 hours.
