## Handling Procedures

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #284 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #284 broth.

Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.

3. Use several drops of the primary broth tube to inoculate a #284 plate and/or #284 agar slant.
  4. Incubate at 20°C for 7 days.
