## Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
4. Incubate the tube at 37°C for 24 hours.

5. After growth has been achieved, use several drops of the suspension to inoculate an additional broth tube, a #18 agar slant and/or a plate.

## Notes

Growth on solid medium may be slightly delayed on initial subculture. Transfer grown broth culture to additional slants or plates. Colonies are entire, raised, circular, smooth, and gray.
