Description

Enterococcus gallinarum strain NCDO 2707 [17R] was isolated from a chicken's duodenum. This whole-genome sequenced bacterial strain was typed as Lancefield's group D and was confirmed by PCR to have the vanC-1 gene. The bacterium can be used in antimicrobial resistance research and drug development.

Handling Procedures

1. Open vial according to enclosed instructions.
 2. Using a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 24 hours.
