Streptococcus pneumoniae strain 262 is a whole-genome sequenced bacterium that was isolated in Arizona from the sputum of a 75-year-old human male. This bacterial culture has applications in susceptibility disc testing and respiratory disease research.

Handling Procedures



- 1. Open thawed vial.
- 2. Aseptically transfer the entire contents to a 5-6 mL tube of #44 broth.

 Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.
- 3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
- 4. Incubate at 37°C for 24 hours in an atmosphere of 5% CO₂.

Notes

An additional transfer may be required after initial 24 hours of growth in order to fully remove cyroprotectant and achieve acceptable growth.
