Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a second tube of broth, a slant,

and/or plate.

5. Incubate all tubes and plate at 37°C for 48 to 72 hours.

### **Notes**

Colonies are yellow, opaque, glistening, and slightly rough.

Cells are Gram-positive motile rod-shaped cells with branched filaments observed in young cultures.
