Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Under anaerobic conditions, withdraw 0.5 ml of #2309 from a single test tube (5 to 6 ml) and rehydrate the vial contents.
- 3. Aseptically transfer this aliquot back into the broth tube. Additional tubes may be inoculated with 0.5 ml each from the suspension.



4. Incubate tubes under an anaerobic atmosphere at 30°C. Incubate one agar plate anaerobically and one aerobically to check for contamination.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- · Use of an anaerobic gas chamber, or
- $\cdot \ Placement \ of \ test \ tubes \ under \ a \ gassing \ cannula \ system \ hooked \ to \ anaerobic \ gas.$

Anaerobic conditions for incubation may be obtained by any of the following:

- · Loose screw caps on test tubes in anaerobic chamber,
- · Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- $\cdot$  Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

#### Notes

Within 24 to 48 hours, growth is evident by turbidity in the broth. This organism can be sensitive so store at 4°C and transfer once per week. No growth should occur on the blood agar plate. Strongly recommend reading Reference #2.
