ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

# **Growth Conditions**

**Medium:** ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood **Temperature:** 37°C

# Handling Procedures

**1**. Open vial according to enclosed instructions.

2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate an additional #44 broth tube, a

# #260 agar slant and/or a #260 plate.

5. Incubate the tubes and plate at  $37^{\circ}$ C for 48 hours. Incubation in an atmosphere of 5% CO<sub>2</sub> is beneficial but is not required for growth.

#### Notes

Pinpoint colonies are evident after 24 hours of incubation. Mature colonies are small and opaque, with smooth surface and entire margin. Beta-hemolysis is evident on sheep blood agar.
