Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

### **Handling Procedures**

- 1. Open vial according to enclosed instructions.**
- 2. From a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**
- 4. Use several drops of the suspension to inoculate #18 agar slant(s) and/or plate(s).**

**5. Incubate all tubes and plates at 30°C for 48 hours.**

On #18 plates colonies are circular, entire, smooth, glistening, and convex, with a yellow pigment.
