## Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #1823 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well
4. Use several drops of this suspension to inoculate a second tube of broth, a slant and/or a plate.
5. Incubate tubes and plate at 20°C for 24 to 48 hours.

## Notes

Colonies on #1823 plates are opaque, round, entire, shiny, and low convex.
