Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Put 6 to 8 ml of ATCC Medium #550 into a 13x100 mm screw cap test tube (small). Add cysteine (3.0% stock concentration, 2 ml/100 ml medium) and then fill the test tube to capacity with ATCC Medium #550. Seal the test tube with a screw cap.
- 2. Let the tube sit at room temperature for 30 minutes before inoculating it with the rehydrated culture.
- 3. Open the freezedried vial according to enclosed instructions.
- 4. Aseptically take 0.5 ml of the pre-reduced medium and rehydrate the pellet.

- 5. Transfer the rehydrated pellet back into the screw cap test tube and close tightly. (The test tube should be filled to capacity). One or two drops can be streaked out onto ATCC Medium #3 Nutrient Agar (BD 213000) plates. This culture grows aerobically in the dark.
- 6. Incubate the culture at 26°C under a tungsten lamp.
- 7. Once growth has been established (24 to 48 hours), the culture should be transferred to fresh broth. If a large inoculum is used (1020%) the medium does not need to be pre-reduced.
