For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

#### **Storage and Culture Initiation**

Frozen ampules packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampules at refrigerator freezer temperatures (generally -20°C).** Storage of frozen material at this temperature will result in the death of the culture.

- 1. To thaw a frozen ampule, place in a 35°C water bath, until thawed (2-3 min). Immerse the ampule just sufficient to cover the frozen material. Do not agitate the ampule.
- 2. Immediately after thawing, aseptically transfer the entire contents to a single 16 x 125 mm screw-capped test tube containing 5 mL of ATCC Medium 1747 broth. Incubate the tube on a 15° horizontal slant with the cap screwed on loosely (loosened one half turn) at 25°C under a 14 hour light (~50  $\mu$ Einsteins/m²/s irradiance)/10 hour dark cycle.

#### **Culture maintenance:**

- 1. Inoculate a tube of fresh medium with 0.1 mL from a growing culture at or near peak density.
- 2. Incubate on a 15° horizontal slant with the cap screwed on loosely (loosened one half turn) at 25°C under a 14 hour light (~50  $\mu$ Einsteins/m²/s irradiance)/10 hour dark cycle.
- 3. Subculture as necessary (i.e., every 14-21 days).

#### Reagents for cryopreservation: Cryoprotective Solution

DMSO, 1.5 mL

Fresh growth medium, 8.5 mL

#### **Cryopreservation:**

- 1. Harvest cells from a culture that is at or near peak density by centrifugation at  $800 \times g$  for 5 min.
- 2. Adjust the concentration of cells to  $2 \times 10^6$   $2 \times 10^7$ /mL in fresh medium.
- 3. While cells are centrifuging prepare a 15% (v/v) solution of sterile DMSO in fresh medium.
- 4. Mix the cell preparation and the 15% DMSO in equal portions. Thus, the final concentration will be  $10^6$   $10^7$  cells/mL and 7.5% (v/v) DMSO. The time from the mixing of the cell preparation and DMSO stock solution to the beginning of the freezing process should be no less than 5 min and no greater than 15 min.
- 5. Dispense in 0.5 mL aliquots into 1.0 2.0 mL sterile plastic screw-capped cryules (special plastic vials for cryopreservation).
- 6. Place the vials in a controlled rate freezing unit. From room temperature cool at -1°C/min to -40°C. If the freezing unit can compensate for the heat of fusion, maintain rate at -1°C/min through the heat of fusion. At -40°C plunge into liquid nitrogen. Alternatively, place the vials in a Nalgene 1°C freezing apparatus. Place the apparatus at -80°C for 1.5 to 2 hours and then plunge ampules into liquid nitrogen. (The cooling rate in this apparatus is

- approximately -1°C/min.)
- 7. The frozen preparations should be stored in either the vapor or liquid phase of a nitrogen refrigerator. Frozen preparations stored below -130°C are stabile indefinitely. Those stored at temperatures above -130°C are progressively less stabile as the storage temperature is elevated. Vials should not be stored above -55°C.
- 8. To establish a culture from the frozen state place an ampule in a water bath set at 35°C. Immerse the vial just to a level just above the surface of the frozen material. Do not agitate the vial.
- 9. Immediately after thawing, do not leave in the water bath, aseptically remove the contents of the ampule and add to a centrifuge tube containing 5 mL of ATCC medium 1747. Centrifuge at 300 x g for 5 min.
- 10. Remove most of the supernatant (=cryoprotectant, which can inhibit growth) and then resuspend the pellet. Transfer the culture to a 16 x 125 mm screw-capped test tube containing 5 mL of ATCC medium 1747.
- 11. Incubate on a 15° horizontal slant with the cap screwed on loosely (loosened one half turn) at 25°C under a 14 hour light ( $\sim$ 50 µEinsteins/m<sup>2</sup>/s irradiance)/10 hour dark cycle.
