Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### **Growth Conditions**

**Medium:**

ATCC Medium 838: Spirillum nitrogen-fixing medium

**Temperature:** 26°C

### **Handling Procedures**

1. Open vial according to enclosed instructions.
2. From a single tube of #838 broth (5 to 6 ml), withdraw approximately 0.6 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
3. Use 0.5ml of this suspension to inoculate a #838 slant and 0.1ml to inoculate #838 plates.
- 4. Incubate tubes and plates at 26°C under aerobic conditions for 48-72 hours.**

5. After 48-72 hours of incubation, wash cells from the slant and transfer this broth to a new slant and plate. Incubate another 48-72 hours under aerobic conditions. This second transfer and incubation is necessary for complete removal of the cryoprotectant, which can inhibit growth.

### **Notes**

Colonies on #838 plates are small, entire, glistening, smooth, and white. This culture will also grown on Tryptic Soy Agar (BD 236950), producing entire, glistening, smooth, translucent, and beige colonies.
