Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### Medium:

ATCC Medium 1907: Rhizomonas medium plus tetracycline

**Temperature:** 30°C

## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #1907 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well. Use several drops of the suspension to inoculate an additional broth tube, a #1907 agar slant

and/or a plate.

4. Incubate all tubes and plate at 30°C for 3 to 4 days.

### **Notes**

Colonies on #1907 agar are circular, convex, entire, smooth, and pinpoint to 1.0 mm in diameter.
