Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #1876 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.

- 4. Use several drops of the suspension to inoculate an additional broth tube, a #1876 agar slant and/or a plate.
- 5. Incubate all tubes and plates at 30°C for 3-5 days to establish growth. Subsequent transfers will grow more rapidly.
