### **Handling Procedures**

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of #1065 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
- 4. Use several drops of this suspension to inoculate a second tube of broth, a slant,



and/or a plate.

- 5. Incubate all tubes and plate at 37°C for 24 hours.
- 1. Open vial according to enclosed instructions.
- 2. From a single tube of #1065 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
- 4. Use several drops of this suspension to inoculate a second tube of broth, a slant, and/or a plate.
- 5. Incubate all tubes and plate at 37°C for 24 hours.
