Handling Procedures

1. Open vial according to enclosed instructions.
 2. From a single tube of #416 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette and use to rehydrate the entire pellet.
 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well
 4. Use several drops of this suspension to inoculate a second tube of broth, a slant and/or a plate.
 5. Incubate tubes and plate at 30°C for 24 hours.

Notes

After 24 hours, growth is evident by turbidity in the broth and the formation of small colonies on the slant and/or plate. Growth is best in broth culture or on biphasic slants.

On #416 agar, colonies are circular, entire, cream, translucent, convex, and smooth.
