Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Growth Conditions

**Medium:**

ATCC Medium 1249: Modified Baar's medium for sulfate reducers

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

**Temperature:** 35°C

**Atmosphere:** Anaerobic

## Handling Procedures

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Under anaerobic conditions aseptically rehydrate the entire pellet with approximately 0.5 mL of #1249 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #1249 broth. Additional test tubes can be inoculated by

transferring 0.5 mL of the primary broth tube to these secondary broth tubes. Best practice dictates the use of pre-reduced media.

3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
4. Incubate in an anaerobic atmosphere at 35°C for 3-6 days. Incubate one agar plate aerobically at 37°C to check for contamination.

**ANAEROBIC CONDITIONS:**

Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

---

**Notes**

It is recommended that 1.5% sodium sulfide is used to reduce ATCC Medium #1249. ATCC has found that this organism will grow in Medium #1249 with or without the addition of 5% ferrous ammonium sulfate. The addition of ferrous ammonium sulfate will cause a black coloration to appear in the media once the organism begins growing, thus making the organism difficult to visualize. Therefore, ATCC recommends that 5% ferrous ammonium sulfate only be used with caution. This organism does not grow on agar.
