Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

- 2. Rehydrate the entire pellet with approximately 0.5 mL of #1955 broth.

 Aseptically transfer the entire contents to a 5-6 mL tube of #1955 broth.

 Additional test tubes can be inoculated by transferring 0.5 mL of the primary

- broth tube to these secondary tubes.
- 3. Use several drops of the primary broth tube to inoculate a #1955 plate and/or #1955 agar slant.
- 4. Incubate at 37°C for 48 hours.

This strain will also grow on ATCC Medium #3: Nutrient Broth/agar.
