#### Handling Procedures

- 1. Open vial.
- Using a single tube of #2025 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #2025 agar slant and/or

plate.

5. Incubate the tubes and plate at 30°C for 24-36 hours under a gas mixture of 97% CO<sub>2</sub>, 3%  $\rm H_2$  .
