Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Under anaerobic conditions, withdraw 0.5 ml of recommended broth from a single test tube (5 to 6 ml) and rehydrate the entire vial contents.
- 3. Aseptically transfer this aliquot back into the broth tube. A slant and a prereduced blood plate may also be inoculated with 0.1 ml each of the cell suspension. An aerobic blood plate may also be streaked to check for purity.
- 4. Incubate tubes and plate under anaerobic conditions at 37°C. Incubate blood plate aerobically at 37°C.
- 5. Within 48 hours, growth should be evident by turbidity in the broth.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- · Use of an anaerobic gas chamber, or
- · Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

· Loose screw caps on test tubes in anaerobic chamber,

- · Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- \cdot Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

Notes

Colonies on #260 agar are entire, circular, smooth, and convex. This organism also will grow on the plates under aerobic condition.

Always use freshly prepared pre-reduced media or pre-reduced media that has been stored under anaerobic conditions.
