Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #1993 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well. Use several drops of the suspension to inoculate an additional broth tube, a #1993 agar slant and/or a plate.



4. Incubate all tubes and plate at 30°C for 24 hours.

Notes

Colonies on #1993 agar are small, round, smooth, convex, entire, and yellow.
