### Description

Enterococcus faecium strain Vancomycin-dependent #4 is a drug-resistant bacterium that was isolated in 1992 from human blood. This whole-genome sequenced strain is resistant to teicoplanin and vancomycin.

Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Temperature: 37°C

### Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #1976 broth (5 to 6 mL), withdraw approximately 0.5 to

- 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #1976 agar slant and/or plate.
- 5. Incubate the tubes and plate at  $37^{\circ}\text{C}$  in an atmosphere of 5%  $\text{CO}_2$  for 24 hours. Loosen the screw caps.

#### Notes

Testing on the source material at the ATCC has shown the presence of revertants that are no longer vancomycin-dependent.
