ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 37°C

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.

5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

On #260 plates, colonies are entire, glistening, circular, smooth, small, flat, and exhibit alpha hemolysis. Incubation in an atmosphere of 5% CO₂ will enhance growth.
