ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 37°C

Handling Procedures

- 1. Open vial according to enclosed instructions.**
- 2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.**
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**
- 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.**

5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

On #260 plates, colonies are entire, glistening, circular, smooth, flat, small, and exhibit α -hemolysis. Using 5% CO₂ enhances the growth.
