**Handling Procedures**

1. Open vial.
  2. Rehydrate the entire pellet with approximately 0.5 mL of #432 broth.  
Aseptically transfer the entire contents to a 5-6 mL tube of #432 broth.  
Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
  3. Use several drops of the primary broth tube to inoculate a #432 plate and/or #432 agar slant.
  4. Incubate at 26°C for 4 to 7 days.
