## **Handling Procedures**

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.6 to 1.0 mL with a Pasteur or 1.0 mL pipette and use to rehydrate the entire pellet.
- 3. Use 0.5mL of this suspension to inoculate a #44 slant and 0.1mL to inoculate #44 plates.
- 4. Incubate tubes and plates at 37°C, under aerobic conditions, for 24 hours.
- 5. After 24 hours of incubation, wash cells from the slant and transfer this broth to a new slant and plate. Incubate another 24 hours under aerobic conditions. This second transfer and incubation is necessary for complete removal of the cryoprotectant, which can inhibit growth.

### Notes

Growth on agar yields colonies that are pinpoint to 1 mm in diameter, circular, entire, and somewhat pulvinate. As culture ages, colonies are larger, off-white, dull, and opaque in the center.
