## Handling Procedures

1. Open thawed vial.
  2. Aseptically transfer the entire contents to a 5-6 mL tube of #1765 broth.  
Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
  3. Use several drops of the primary broth tube to inoculate a #1765 plate and/or #1765 agar slant.
  4. Incubate at 26°C for 4-7 days.

## Notes

This strain can form a pellicle at the surface of the broth tube, or growth may be observed as clumps of cellulose floating in the medium, but broth itself remains clear.
