## Handling Procedures

1. Open vial according to enclosed instructions.
  2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate pellet.
  3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
  5. Incubate all tubes and plate at 30°C for 24 hours.

## Notes

Two colony types are observed on #3 agar, 1) Circular, entire, low convex, dull, and semi-translucent, and 2) Irregular with a halo, raised, dull, and larger than type 1. Additional information on this culture is available on the ATCC® web site at [www.atcc.org](http://www.atcc.org).
