### **Handling Procedures**

- 1. Immediately prior to working with the culture place the frozen vial at room temperature to thaw.
- 2. Aseptically transfer the entire contents of the vial into a single broth tube (5 6 ml) of #1065 broth. Mix well. Additional tubes can be inoculated by transferring 0.1 ml to slants and 0.5 ml to broth tubes.
- 3. Use several drops of the suspension to inoculate a #1065 plate.
- 4. Incubate the tubes and plate at 37°C for 12-24 hours.
