Handling Procedures

1. Open vial.
 2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the pellet.
 3. Aseptically transfer the rehydrated pellet back into the tube. Mix well.
 4. Use several drops of this suspension to inoculate #18 slants and/or plates.
 5. Incubate all tubes and plates at 30°C. Growth should occur in 24 hours.
