Handling Procedures

1. Open vial according to enclosed instructions.
 2. Using a single tube of #1687 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate an additional broth tube, a #1687 agar slant and/or a plate.
 5. Incubate all tubes and plate at 30°C for two to four days.

Notes

On #1687 plates colonies are tiny, glistening, yellow, and smooth. Two colony types may be observed, but they identify as the same organism.

This is a slow-growing organism. The doubling time under the conditions listed above is 4 to 6 hours. To minimize lag time, inoculate a 125 ml flask containing 50 ml of the recommended medium and grow on a shaker.

The recommended medium is that used by the depositor to induce the PCP degradation by adding a PCP solution for a final concentration of 50 ppm. The strain will also grow on Tryptic Soy Agar producing colonies that are small, entire, glistening, yellow, smooth, and pulvinate.
